In FY2024 (July 2023-June 2024), the Foundation raised more than \$2.5 million dollars to support the capital needs of LifeFlight of Maine. In that time period, the Foundation transferred \$1,230,403 to LifeFlight to meet those needs. Purchases included: a used ambulance; replacement medical equipment; equipment for LifeFlight Aviation Services, such as an aircraft de-ice system for the fixed wing at the Bangor hangar and ; a Mass Notification System; an accounting/financial mgmt. software system; portable landing zone kits for distribution to EMS partners; safety and survival equipment; and crew uniforms. The Foundation also provided "startup" salary support for several new LOM positions, including the Director of Client Relations, two part-time and one Senior Educational Coordinator, and support/travel expenses for

The LifeFlight Foundation is responsible for the planning an execution of all marketing and communication efforts for both the Foundation and LifeFlight of Maine. This includes a multi-faceted outreach strategy to a range of constituents, including donors, partners, and patients from across Maine. The Foundation produces several print pieces, negotiates advertising and partnership arrangements, oversees all social media, and is in the process of completing a comprehensive crisis communications plan.
